Outgoing President's Message

Dear PCRS Members & Supporters,

It has been an honor to serve as the President of this wonderful and thriving organization. During my tenure, I was able to build on the groundwork laid by my amazing predecessor, Tamara Tobias, who had helped to establish important dedicated subcommittees, each led by a PCRS Director: the Abstract/Awards, Scholarship, Grant, Membership, Program, and Social Media/Communications Committees. By strengthening these committees, we were able to solidify our organizational structure and increase member engagement.

Another focus of my tenure was to emphasize and nurture the multidisciplinary nature of our society. Our favorable and stable financial situation over the last few years allowed us to expand the PCRS scholarship program, with an emphasis on including more APPs, nurses and other allied health professionals. Under the leadership of Scholarship committee chair Lindsay Kroener, the number of scholarships awarded to non-MD/DO PCRS members increased sharply. In the years to come, we hope that PCRS members from all segments of the multidisciplinary reproductive care team, including nurses, embryologists, and genetic counselors will take on responsibilities and leadership roles within the organization.

Given the financial stability achieved in the post-Covid years, we initiated a thorough financial review to ensure that society savings are safely managed and invested. This will allow us to be prepared for the occurrence of another unforeseen crisis such as the pandemic which severely affected the annual meetings in 2020 and 2021.

With regards to the venue of the meeting: as the terms and conditions of our established hotel were about to change in a very unfavorable way, we conducted a search for a new venue that would maintain both the geography and the spirit of the annual meeting. Spearheaded by our event manager Marcy Hilecher, we identified a suitable property for the 2026 annual meeting that checks all the boxes- the Westin Rancho Mirage Golf Resort & Spa. It even comes with several advantages compared to the previous location: a lower food and beverage minimum, a higher capacity and the ability to have the entire property to ourselves for the duration of the conference.

The 2025 annual meeting, as usual the highlight of the year for our society, was yet again a great success. The attendance record from the 2024 meeting was again broken, with 550 attendees, excluding vendors and sponsors. Revenue exceeded budget projections, and the feedback from conference attendees was unanimously positive. The success of the meeting was a result of amazing efforts by many PCRS members, first and foremost the Program Committee under the leadership of Nicole Doyle. Every single program item, including breakout sessions, workshops, lectures and debates, was outstanding and well received. Like every year, the meeting would not have been possible without our industry partners, who showcased their latest innovations and enabled us to network and learn. On a personal level, the revival of the "Richard versus Richard" PGT-A debate (which I also moderated as Program Chair in 2017) and the Oktoberfest-themed PCRS Celebration Dinner were highlights of the conference. I was very touched that my wife and kids, as well as my parents, brother Philipp (REI in Switzerland) and my entire Solana Beach work team were able to make it to the meeting.

One of the reasons why our organization is doing so well is the great work done by the team at SBI Association Management, and I would like to extend my gratitude to them for their services over the past year. A special word of thanks goes to Adam Carranza, PCRS executive director during my Presidency—it was a pleasure and a privilege to work with him on a professional and personal level. He accepted a new position with the National Kidney Foundation, a cause that holds deep personal meaning for him, in May 2025, and we all wish him the best of luck.

It was my pleasure to pass the Presidential baton to my longtime friend Jason Franasiak, a thought leader in our field who has been dedicated to the society for many years. He will continue to foster the spirit of the organization, and the core values of our PCRS family: supportiveness, professional and personal development, innovation, inclusiveness and collegiality.

I look forward to seeing you at the PCRS 2026 Annual Meeting.



Abstract Submissions

PCRS continues to be a global, interactive organization promoting leadership and innovation in reproductive medicine within a collegial environment. The annual CME program is based on the integration of clinical practice, scientific research, and education in the field of reproductive medicine.

More than one hundred and twenty abstracts were selected for oral or poster presentation at the 2025 annual meeting and were also published in a special digital edition of Fertility & Sterility.



Scholarship Program

To encourage the participation of medical professionals in-training, particularly fellows specializing in reproductive medicine, PCRS established a Scholarship Program made possible by funding from Society members and commercial sponsors.

Scholarship Types & Eligibility Requirements

MD Scholarship

Open to all fellows in US REI programs, residents, and medical students who have not previously attended PCRS on a scholarship.

Merit Scholarship

Open to any PCRS scholarship winners from previous years who will be the presenting author of an abstract submitted for presentation at the meeting.

REI Lab Scholarship

Open to all non-management IVF laboratory professionals who are the presenting author of an abstract submitted for presentation at the meeting.


Nurses and Genetic Counselors




Revenue from Exhibit Fees




Revenue from Attendee Fees
